In exercise of the powers conferred by sub-section(1) of section 180 of the Electricity Act, 2003 (Central Act 36 of 2003) read with Regulation 29(1) of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, the State Government do hereby direct that the following amendments shall be made in the Regulation framed under Regulation 29(1) of the said Regulation published in the notification of the Government of Odisha in the Department of Energy No. 9553, dtd. 3<sup>rd</sup> December, 2014, namely :-

A M E N D M E N T


1. In the said regulations for Regulation 21, the following regulation shall be substituted, namely:-

“21. MINIMUM AGE FOR OBTAINING SUPERVISOR CERTIFICATE OF COMPETENCY (SCC): The candidate for the examination for Supervisor Certificate of Competency shall be a person not below the age of 21 (twenty one) years on the date of application. Whereas the candidate applying on exemption basis for Supervisor Certificate of Competency (SCC) shall be a person not below the age of 23 years on the date of application.”

2. In the said regulations in Clause (c) of Regulation 25, the following regulation shall be substituted, namely:-


“(c) If the license is sought for a partnership firm, the firm must have submitted partnership deed or if the License is sought for a registered company, the same must have been registered with the Registrar of Companies. In case of a partnership firm all the partners of the firm and in case of a registered company the Board meeting may approve to issue an authorization letter to the authorized signatory to sign the application on behalf of the firm or company as the case may. The Authorization letter shall be on Rs. 100/- stamp paper.”
